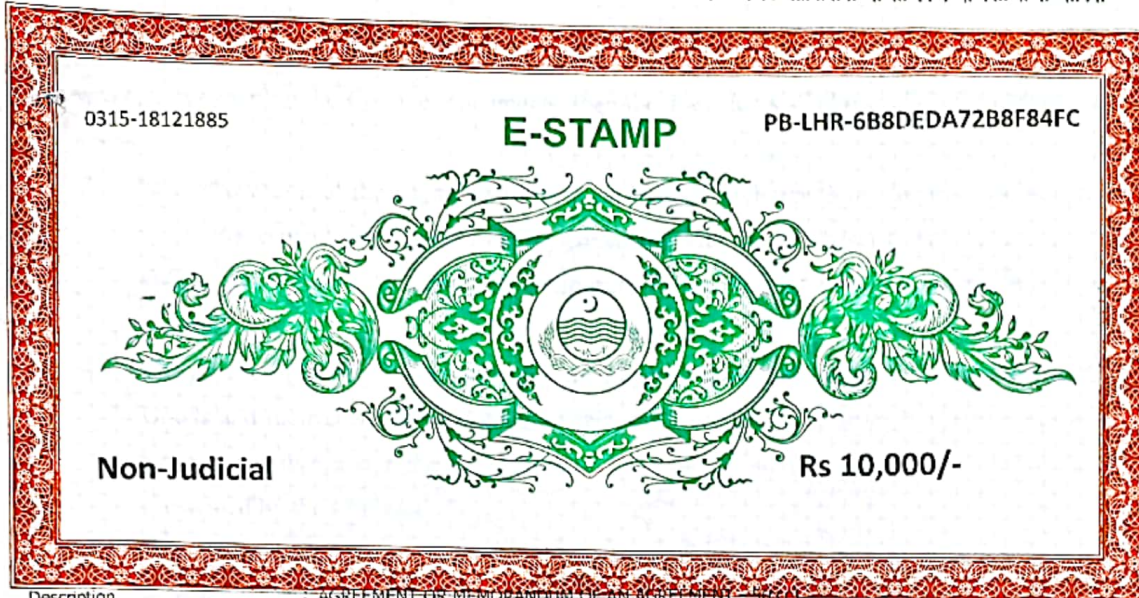

THIS AGREEMENT made on the 21st day of July, 2022, between **Municipal Committee Burewala** (hereinafter "the Purchaser"), of the one part, and **Sumico Technologies Pvt Ltd.** (hereinafter called "the Supplier"), of the other part:

WHEREAS the Purchaser invited bids for "Provision of Machinery & Equipment's for improvement of Solid Waste Management in Burewala City" (As per scope of work and terms & conditions prescribed in the Bidding Documents), and has accepted a Bid by the Supplier for the supply of those Goods in the sum of **Rs,8,11,24,800/- (Eight Crore , Eleven Lac, Twenty Four Thousand, Eight Hundred Only)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

 - (h) Drawings; and
 - (i) Any other Item

3. In consideration of the payments to be made by the Purchaser to the Supplier as indicated in this Agreement, the Supplier hereby covenants with the Purchaser to provide the Goods and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Purchaser hereby covenants to pay the Supplier in consideration of the provision of the Goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
5. All dispute of differences between the parties of connection with or arising out of this agreement shall be settled in accordance with the provisions of relevant clause of the conditions of contract.
