INVITATION FOR BIDS

Government of Pakistan has received a loan (credit No. 6243-PK) from the International Development Association (IDA) for funding of Punjab Cities Program (PCP) and intends to use part of the funds to cover eligible Payments under the contract for sub-project "Construction of SWM Parking Area in Burewala City". The program will be implemented under the control of Punjab Municipal Development Fund Company (PMDFC).

The Municipal Committee Burewala invites sealed bids from eligible bidders who can prove their eligibility and qualification as mentioned in the Bidding Documents for the works and have not been Black Listed by any Government Agency/Department/Organization/Donor etc. The Bidding is open to All Eligible Bidders.

Bidding process of works mentioned below shall be carried out in accordance with Punjab PPRAs Rules 2014 and revised procedures thereon.

Basic Eligibility: The Municipal Committee Burewala invites sealed bids under PPHA Rule 38(2)(a) **Single Stage-Two Envelope (SSTE)** bidding procedure from eligible Constructor/firms or persons licensed by the Pakistan Engineering Council in C-4 and above.

Bidding/Tender documents issuance: Bidder may obtain, immediately the bidding documents from the address mentioned below during office working hours upon payment of an amount of Rs. 10,000/- (Non-refundable) in cash till 03/05/2023 during office hours. Bid must be accompanied with 5% of the Estimated Cost of scheme as Bid Security in shape of CDR/Bank Draft/Pay Order in the name of Municipal Committee, Burewala from a Scheduled Bank of Pakistan and must be attached with **Technical Bid**. If the Bid Security is not found attached with the Technical bid or amount of bid security is less than given amount, the bid will not be considered for evaluation and will be rejected straight forwardly. Technical bids will be opened on the same day i.e. 04/05/2023 at 02:30 pm in the office of Municipal Officer Infrastructure, Municipal Committee Burewala by the Procurement Committee in the presence of Bidders or their Authorized Representatives who choose to attend as specified in the bidding document. The Financial proposal of technical qualified bidders will be opened subsequently. Conditional, Un-signed, Incomplete, cutting, overwritten and doubtful bids will be dealt as rejected.

Financial Bids are required to be submitted on **Item rate basis** (not on the basis of MRS with percentage premium) and the rates and amounts must be filled by the bidder for each item in the Bill of Quantities and quote the total price.

If the bid amount of successful bidder is seriously unbalance in relation to the Detailed Estimate, the bidder shall have to furnish additional Performance Security equal to the difference of Estimated Cost and the total bid amount in the shape of Bank Guarantee duly issued by any Scheduled Bank of Pakistan as per satisfaction of the Municipal Committee, Burewala besides furnishing detailed price analysis to demonstrate internal consistency of his rates as per Clause 18.28.4 of bidding document. When work order issued to approved contractor. He has to make the agreement work department on stamp paper of value specified Government.
