The above scheme was considered and approved by the Divisional Development Working Party in its meeting held on 05-01-2022.

Furthermore, Schemes involving acquisition, transfer and mutation in case of private and Government land involved for a scheme must ensure mutation, transfer and acquisition of land in favour of the Government or concerned Administrative department before the commencement of work on ground. **Work order shall not be issued until mutation / transfer of land to the Client department / agency has been successfully completed.** In case of failure, Client department & executing agencies shall be held solely liable and face all the consequence
