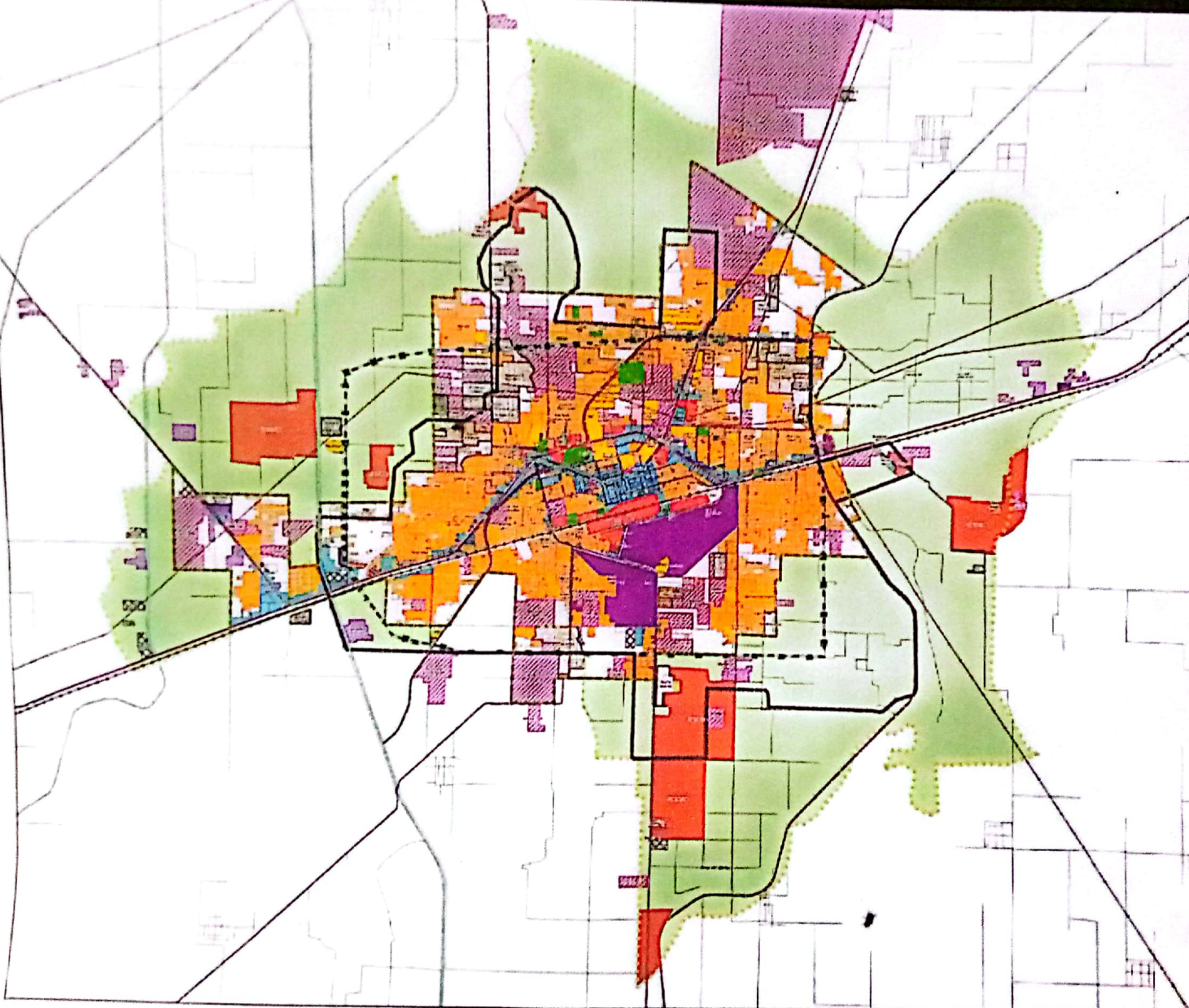
Land Use Classification Map of Municipal Committee Burewala
