
NOTIFICATION

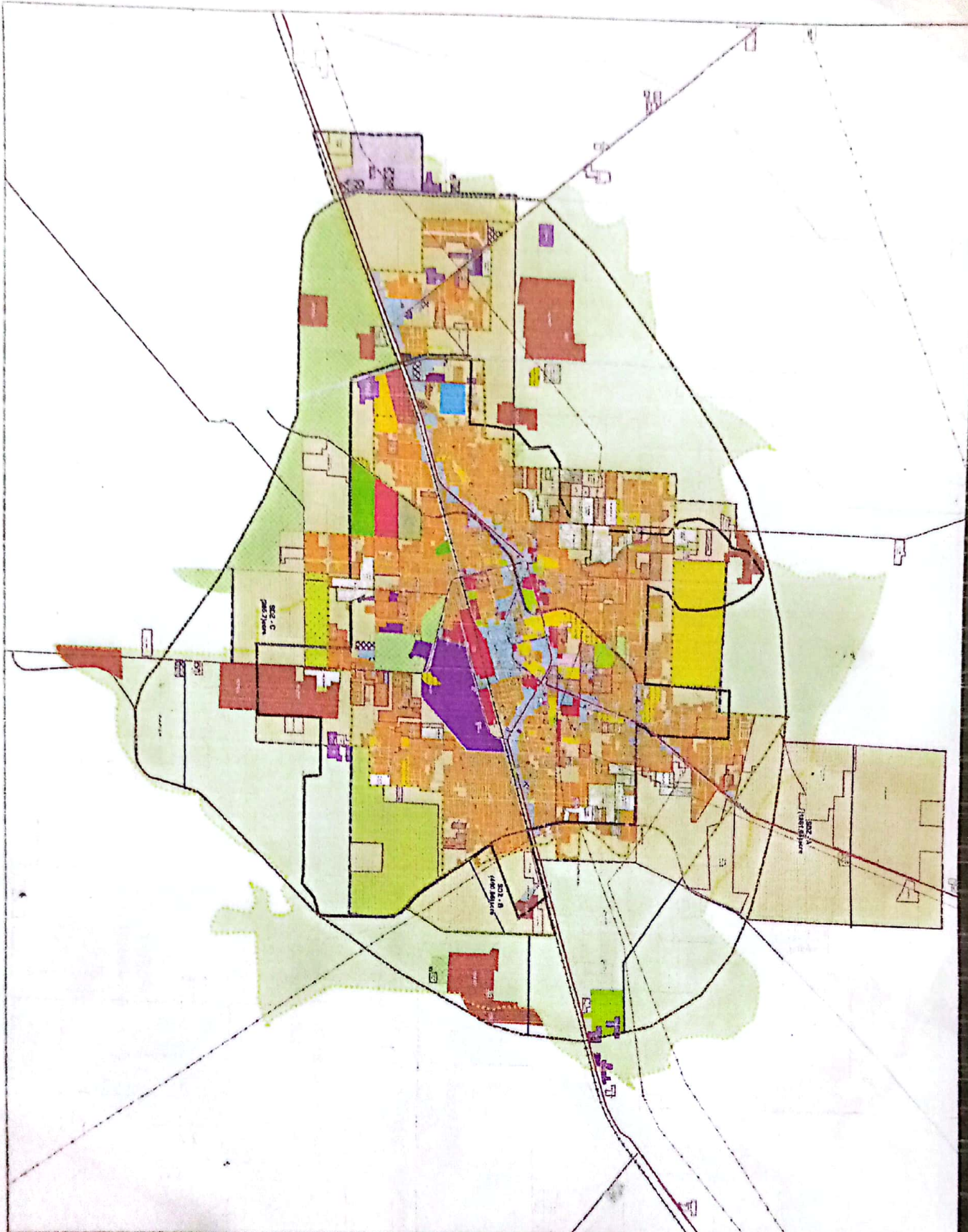
